



2023 Kids Club Service Agreement

Welcome to Kids Club! All children between the ages 1-years old may be enrolled.

1. Reservations are required for every child using our Kids Club and must be made 24 hours in advance. **No drop-ins.**
2. Cancellations must be made eight hours in advance to receive a refund — no refund for no-shows.
3. There is a one-hour minimum charge of \$12.00 for members or \$15.00 if using a Day Pass or Punch Card that day. Maximum of two hours total. A fee of \$15 will be assessed if you are late picking up your child by more than five minutes.
4. A parent/guardian must be at BIRC at all times. You may be contacted periodically to address your child's needs (toileting, diapering, feeding, upset child, etc.).
5. In consideration of others, sick children will not be allowed in the Kids Club. If a child becomes ill during their stay, the parent/guardian will be contacted immediately.
6. Due to health code regulations, Kids Club personnel cannot change diapers. Staff will contact a parent/guardian if a diaper change or toileting is needed.
7. In the interest of children with food allergies, food is not allowed in the Kids Club. Bottles and sippy cups are permitted.
8. Do not bring any toys from home. Kids Club has age-appropriate toys that we wash/sanitize regularly.
9. Bainbridge Island Recreation Center (BIRC) reserves the right to refuse service to children who are unruly or who exhibit continuously inappropriate behavior. The decision to refuse service shall be the sole discretion of Bainbridge Island Metro Park & Recreation District.
10. For health and safety reasons, we require that children always wear shoes and/or socks. Flip-flops and sandals are not allowed.
11. Each parent/guardian with a child in the Kids Club will be issued a wristband. The wristband must remain on until the parent/guardian picks up the child and leaves the facility.

The signature below acknowledges that the parent/guardian has read, understood, and agreed to abide by the foregoing policies. The parent/guardian agrees to indemnify and hold Bainbridge Island Metro Park & Recreation District and its employees harmless from any claims for damages or injury their child(ren) may cause or inflict on any other child and releases Bainbridge Island Metro Park & Recreation District and its employees from any claims, demands or liability which may arise out of providing Kids Club.
